## LODGING AGREEMENT



PRETTY PAWS reserves the right to change your dog's type of boarding, and or to provide or decline additional services, if it is necessary to protect the health and well-being of your dog, other dogs, or our staff.

(Additional charges may apply.)

1. Vaccinations: All dogs must be current on : **Vaccinations against Rabies, Bordetella, Distemper, Parvovirus and Leptospirosis (or DHLPP) this vaccines must be given by a license Veterinarian ONLY.**
2. Flea and Heartworm: All dogs must be current on flea and heartworm prevention programs.
3. If your dog is exhibiting any symptoms that may suggest illness such as sneezing, coughing, wheezing, runny eyes or nose, vomiting, lethargy, or diarrhea, please do not bring your dog to our facility.
4. Dogs with flea or tick problems will be treated at your expense.
5. Un-Spayed females in heat will not be accepted. Although we accept un-neutered males and un-spayed females (not in heat) for boarding services ONLY, PRETTY PAWS is not responsible for unplanned breeding.
6. Dogs participating in Daycare activities over the age of 8 months must be spay or neutered. This is a case-by-case basis.
  - a. I understand that PRETTY PAWS has relied upon my representation that my dog is in good health and has not injured or show aggression or threatening behavior to any person or dog in admitting my dog for services.
  - b. I understand and agree that PRETTY PAWS will not be liable for any injuries or illnesses that occur as a result of my dog(s) attendance, provided that reasonable care and precautions are followed.
  - c. I further understand that there are risks and benefits associated with group socialization of dogs. I agree that the benefits outweigh the risks and that I accept the risk. I desire a socialized environment for my dog while attending daycare and while in their care. I understand that while the socialization and play is closely and carefully monitored by staff members to prevent injury, it is still possible that during the course of normal play my dog may receive minor nicks and scratches from roughhousing with other dogs. Any injuries to my dog will be pointed out by staff upon pick-up.
  - d. I understand that if my dog is not picked up on time or by a date specified in a separate agreement, I hereby authorize Elite Pet Resort to take whatever action is deemed necessary for the continuing care of my dog. I will pay the cost of any such continuing care upon demand. I understand that if I do not pick up my animal, Elite Pet Resort will proceed according to the guidelines provided by Texas penal code, 542.092 regarding abandonment of animals by an owner. I also acknowledge that I will fully be responsible for all attorneys' fees.

I understand that PRETTY PAWS is not a veterinary establishment and does not practice veterinary medicine. I understand and agree that if my dog(s) become ill or injured, or if the state of the dog(s) being health requires medical attention, PRETTY PAWS, in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the dog. PRETTY PAWS staff will make their best efforts to notify me in the event of a serious illness or injury using the contact information I have provided to PRETTY PAWS. I understand that I am responsible for providing updated contact information. I agree to assume full financial responsibility for any and all expenses incurred, and I release PRETTY PAWS and its staff from any and all responsibility for, or claims, damages, debts, arising out of or related to such medical care, including, but not limited to, transportation to. From the veterinary clinic and choice of veterinarian and animal hospital.

- e. I certify, to the best of my knowledge, my dog(s) has not been exposed to any communicable diseases within the past 30 days. I agree that I will notify PRETTY PAWS of any known exposure of my dog(s) to communicable diseases and will keep my dog(s) out of boarding and daycare services and will provide a veterinary certification of fitness for boarding to be admitted or readmitted. I also agree that I will maintain current vaccines for my dog(s) and provide certification to that effect upon initial evaluation and periodically as requested.
- f. I authorize PRETTY PAWS to obtain medial and vaccination records for my dog(s) from the veterinarian listed above, and I hereby authorize my veterinarian to provide these records to PRETTY PAWS.
- g. I understand and agree that I am solely responsible for any and all acts of behavior from my dog(s) while in the care of PRETTY PAWS. I release PRETTY PAWS from any liability arising from my dog(s) attendance at PRETTY PAWS and accept full responsibility for any and all costs for injury to staff or other animals or damage to facilities caused by my dog(s). I hereby release PRETTY PAWS of any liability and I further agree to indemnify and save them harmless against any and all claims arising from my dog(s) attendance at PRETTY PAWS including but not limited to all costs, damages, attorney fees, expenses and liabilities in connection therewith.
- h. I understand that in an emergency even, such as a natural disaster, every effort will be made to contact me to retrieve my dog(s). I agree that PRETTY PAWS, in its sole discretion, is authorized to transport and/or make temporary alternative arrangements to house and care for my dog(s).
- i. I understand and agree that my dog(s) may be photographed, videotaped and/or recorded and that PRETTY PAWS retains all the rights to use, and proceeds from us of, images.
- j. I have received a copy of the PRETTY PAWS "Lodging Policies: and agree to the terms and conditions set forth within.
- k. I understand that this agreement covers the current relationship between PRETTY PAWS and me. Each time I bring my dog(s) to PRETTY PAWS, I am affirming the terms of this Agreement and the truthfulness and accuracy of all statements I make in this Agreement.
